## **Insights from Primary Care: Join the conversation**

We had the pleasure of attending the PCPA Leadership Conference in London last week – the first time PCPA have run this event, which was a sell-out and a huge success.

We not only had the opportunity to host an exhibition stand on the day but were also invited to talk to delegates before attending their first workshop. We took the opportunity to gather insights and feedback from PCPA members on the current challenges they face.

Most delegates were from Primary Care Networks (46%), with others from ICBs and a handful from Primary Care (general practice). We gathered the following results from a survey of these delegates:

#### Top tasks performed day-to-day?

- 1. Medication reviews/monitoring/SMRa
- 2. Out of stock/access to meds
- 3. Medicines Reconciliation
- 4. De-prescribing
- 5. Prescribing

#### **Top challenges?**

- 1. Capacity/workload
- 2. Lack of time
- 3. Lack of joined-up working
- 4. Out of stock issues
- 5. Staffing/workforce

#### What makes technology good?

- 1. Ease of use/accessibility/speed and user friendly
- 2. Integration and seamless working
- 3. Connecting people and teams
- 4. Connectivity
- 5. Data sources, up-to-date and access to resources

#### How to fund new solutions?

This was an emotive topic, particularly around processes feeling long, complicated and time consuming, feeling impossible at time.

- 1. Business Cases
- 2. Pilots
- 3. Data
- 4. Engaging Stakeholders
- 5. ICB

We'll be using this research to dig deeper into some of the challenges, to see where Optum can make an impact with our products and services. We welcome the report published this week by RPS on <u>Medicines Shortages: Solutions for Empty Shelves</u> as this topic appeared in the top daily tasks and challenges. #### **Optum Quantity Limit Switches**

Selected by our clinical team from careful analysis of national prescribing data to identify high-impact, overprescribed products.Continuing our ongoing collaboration with NHS England around antimicrobial stewardship, we have developed a new and updated set of quantity limit switches for antibiotics to limit to a 5-day supply. These are often prescribed for longer than is recommended by NICE for respiratory tract infections.
